Ok, sorry to be long-winded, but I had to assure you that you weren't wasting your time. As I told President Trump in my email to him today (via his website portal -- it's attached to my email, here), I'll cut to the chase & be brief:

As you know, your 2 Senatorial runoff races are very important to the balance of the U.S. Senate, but what you probably don't know is just how much the deck is stacked against you -- what long odds and obstacles you face, so I endeavor to tell you what I saw when I was doing research for my election coverage just now:

First, in case you missed it, the GOP gained a few seats this time in the House, but I suspect you overlooked fact that we lost big-time: Our GOP message (especially with a popular U.S. President) should have come VERY close to a 435-0 sweep: ALL HOUSE SEATS were up for reelection (as they are each time). However, we not only lost, but we lost the House TWO TIMES IN A ROW, handing the gavel to Speaker Pelosi.

This is VERY relevant in our GOP Senatorial races because the House races are a VERY accurate metric of the "actual" pulse of the nation: ALL the races are up for reelection, reflecting ALL districts in America, so a GOP loss (especially twice in a row) indicates that the GOP has lost voters. This could be for any/all of 3 reasons:

(#1) First, we've seen widespread Election Fraud -- however, I'm not a paranoid conspiracy theorist: Most of the election fraudsters hurriedly tampered with ONLY the presidential election (which was VERY different than most other GOP races, something you don't expect unless there's ballot tampering). So, "Election Fraud" is probably not a factor in *your* races. (Especially with many poll observers giving you scrutiny: You will get a "fair" race--trust me.)

(#2) Secondly, End Times Biblical prophecies tell us that the world will get progressively more Liberal (lovers of abortion, greed, etc.), and that does account for *some* of the GOP losses, but NOT all.

(#3) "When you have eliminated all which is impossible, then whatever remains, however improbable, must be the truth." (Sherlock Holmes)

OK, Sherlock Holmes is fictional, but what he says is true: The only thing left to blame for the GOP's back-to-back House losses... is the GOP. (The Senate, which has only 1/3rd of its races up each term, "got lucky," but WILL lose GOP control if you don't change course.)

After careful analysis, I've identified FIVE (5) areas where GOP lawmakers VERY OFTEN (and President Trump, occasionally) royally screw up, and commit "unforced errors," aka self-inflicted wounds, and here they are:

#1 -- First, just so you know, I do NOT use any drugs, nor do I advocate any "recreational" or "legalized" drug use (like many liberals), but the GOP does not know the difference between "Medical Marijuana" and "recreational pot." Why is this important to you? Well, in Florida's last statewide election, all GOP candidates won, except one: Nikki Fried, a liberal Democrat, won Agriculture Commissioner. Does anyone know why? Yes-- she was a VOCAL advocate of Medical Marijuana, and her opponent got beat. (Remember him? I didn't think so: Nikki Fried gave him a beatdown!) In fact, Sen. Rick Scott (one of my favourite lawmakers, for his fiscal & social Conservative views) ALMOST got beat by Bill Nelson. You know why Nelson didn't win? Because HE TOO was a clueless, out-of-touch candidate on Medical Marijuana. Lest you doubt me, notice that Ninety-One (91%) Percent of ALL Americans support medical marijuana:

"Around nine-in-ten Americans favor legalization for recreational or medical purposes [] In addition to asking respondents about whether marijuana use should be legal in general, the Center asked a separate group of respondents about legalizing marijuana for medical and recreational use. Nearly six-in-ten Americans (59%) favor legalizing marijuana for medical and recreational use, while another 32% say it should be legal for medical use only. Only 8% say it should not be legal." Reps. Gaetz and Steube use common sense, and they get reelected. Nikki Fried's opponent and Rick Scott's opponent, last election, did NOT support common sense *medically safe* marijuana measures. They both got an electoral beatdown. Be like Gaetz and Steube, and you'll reduce headwinds.

In other words, if you're a vocal advocate for protecting/upgrading & hardening the "Grid," it'll probably help you pick up votes, especially from GOP voters who appreciate your support for President Trump's Executive Order. (Besides, if you like being able to call 911, have electric or internet utilities, or healthy satellites, my research in very important.)

(As a contrast to the "grid" issue, many Liberals complain about Global warming, and I note that Sen. David Purdue, like me, doesn't consider Global Warming to be a major threat. However, in case you need some 'hard science' to help you, please see my section on Global Warming, in the FAQ white paper I've included in the attachments: One thing you should know: Mars has LOTS more CO2 than earth, but NO global warming problems--in spite of how close Mars is to the sun: "Things that make you go: 'hmm...!'"

#3 -- Third, did you see President Trump's **“Executive Order on Lowering Prices for Patients by Eliminating Kickbacks to Middlemen,”** Issued on: July 24, 2020: <https://www.Whitehouse.gov/presidential-actions/executive-order-lowering-prices-patients-eliminating-kickbacks-middlemen/>

In case you don't know, both PolkCare and Hillsborough County indigent healthcare (both are ""County plans" in FLORIDA) are AFFORDABLE because they eliminate the insurance middleman. The "Affordable" Care act is NOT affordable, and it's because there's an evil, greedy insurance middleman. I'm not a big fan of Federal Government involvement in healthcare (preferring to let states/ counties handle it, and they handle it VERY well, trust me, or ask around). But if you must, then please help Pres. Trump -- and (more-importantly), be a VERY VOCAL advocate of all these issues (if you wanna get votes), letting GOP voters know you support President Trump, and letting Liberals & Swing voters know you care about bipartisan healthcare solutions.

#4 -- Fourth do you remember **Pres. Trump's 3/19/2019 legislative request in FORBES to cut pork spending?** Loan Limits ARE spending cuts. *Why?* Because tax\$\$ are used to make/back these

Well, GOP lawmakers SAY they support Trump, but why haven't any GOP lawmakers introduced a bill to grant Trump's pork spending cuts request, above? (I've attached 2 versions of just such a bill.) My guess is for 2 reasons: (i) Lack of courage/spine; and (ii) Without student loans bankruptcy to operate as a Free Market check on excessive lending, the liberal/Swamp Higher Ed lobbyists won't "get the message" and back off--thereby allowing Trump's NECESSARY pork spending cuts to pass into law: IF YOU DISAGREE with this hypothesis, plz explain to me why GOP lawmakers have NOT tried to get said pork spending cuts passed? (-crickets-) - My theory is right.

#5 -- Fifth and last, I must address the "GOP Elephant in the room," a taboo, but necessary issue: H.R.2648 and its companion bill, S.1414, restore bankruptcy to student loans. Now, in case you didn't know, the U.S. Constitution's Uniformity clause REQUIRES that U.S. Bankruptcy Code be uniform, and that it is NOT. These bills (which you should support for the right reason -- not merely to get much-needed votes) would restore this constitutional flaw in the law.

Bankruptcy uniformity is not a liberal free handout, but rather CONSTITUTIONAL RIGHT, as guaranteed by the Uniformity clause: Look it up. (*I'll give you a hint: Art.I, Sec.8., clause 4, U.S. Constitution.*) **OBEY THE CONSTITUTION --or we will keep losing elections.**

Here's a summary of what will happen of GOP lawmakers fail to vocally advocate H.R.2648 and S.1414 (the Student Loan Bankruptcy bills):

- 1) Lose votes big-time: **Over 44.7 Million Americans hold student debt, and another 30-40 Million are cosigners, or family/friends.**
- 2) Violate the U.S. Constitution's Uniformity clause (a special type of Equal Protection)
- 3) Violate Jesus's golden rule, which was the basis on which number (2) above was patterned. (Sorry if anyone is offended by me "getting religious," but all --or almost all -- of us GOP Republicans claim to be "Christians," eh? Well, let's practice what we preach, and "be real" -- or else lose votes.)
- 4) Without bankruptcy as a Conservative Free Market check on predatory lending, lobbyists will have NO force to check them, and they will continue to oppose Pres. Trump's pork spending requests above. (If you disagree with me, then please tell me: Why haven't GOP lawmakers even TRIED to get Trump his loan limits aka pork spending cuts request above? --Crickets--.) Thus, I will respectfully ask Sens. Loeffler & Purdue to cosponsor S.1414 (H.R.2648 is companion bill), Student Loan Bankruptcy. Only WITH the sword of bankruptcy (aka Economic 2ND Amendment) back in students' hands will the lender (Dept of Ed, using MY tax\$\$) "think twice" about loaning obscenely large amounts, & lobbyists will "see the handwriting on the wall," **BACK THE HECK OFF**, and allow lawmakers to grant your loan limits request in **_#4_** above, as described in the **Forbes** Magazine article.
- 5) Furthermore, **Dr. A. Wayne Johnson, Conservative Republican, who was a recent COO (Chief Operating Officer) of the U.S. DEPARTMENT OF EDUCATION'S Federal Student Aid Program, is probably the nation's top expert on American Higher Education lending—and he estimates that more than EIGHTY-FIVE (85%) PERCENT of Student Loans in American Higher Ed will NEVER be repaid:** QUOTE: "There is an unlimited insatiable appetite on the part of the colleges to encourage students to take out loans." [] He emphasizes that 44 million people owe student debt. **"And more than 85 percent of these loans will never get repaid. It's a poison students don't recognize they are getting into when they take out loans. They don't realize until later in life that it will eat their life away."**

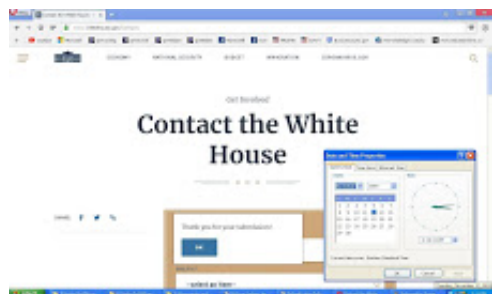

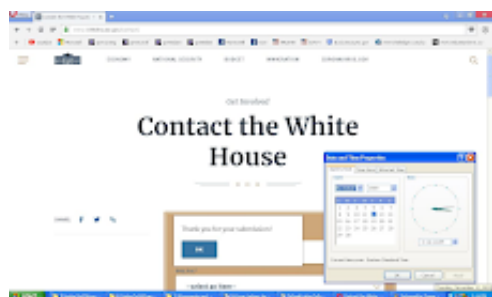
